

ThinkItBookIt.com Privacy Policy

ThinkItBookIt.com (hereafter, “website”) is designed to give the very best of services in the area of travel planning and reservations. These services are provided to assist all users (collectively all “visitors” to the website like “surfers” – just looking for information, “members” – who have registered “membership accounts” on the website and have provided some “membership information” or “account information” and “customers” – who actually make a purchase). These services are provided with the intention of assisting all users in making legitimate travel reservations and otherwise transacting business with travel related goods and services, in accordance with the Terms & Conditions (hereafter, “Agreement”) of the website.

ThinkItBookIt.com is owned and operated by Think It Book It Travels (hereafter, “company”). The company is a licensed travel agency in the province of Ontario, Canada; and as such, it offers the service of providing travel information and reservations, as provided by various third party suppliers, to the customers.

ThinkItBookIt.com Privacy Policy is designed to give you full scope of all the services provided by the website. At the same time, it also gives you information regarding protecting your privacy as well as to give you information regarding the practices adopted by the website that make your online conduct safe. This document describes the use and sharing of Personally Identifiable Information (hereafter, “PII”). PII includes user’s full name, email address, telephone number/s, credit card number/s, or any other membership information. NO pricing is guaranteed until ticket is issued. In case of any inconsistent or inadvertent occurrence, you shall be contacted within one business day to seek further arrangements.

ThinkItBookIt.com is for your personal use subject to your acceptance, without modifications, of the Terms & Conditions (hereafter, Agreement) of the website and the company. The Terms & Conditions document is available for review on [_____provide link\)_____](#) There is no need to repeat the full Terms & Conditions here just concentrating on some portions and on data sharing is enough_____. Any user/s using this website for any of the services offered indicates his / her / their complete acceptance of the Terms & Conditions in full.

Warning: The website notifies you about the information collected, about the collectors of the information, the reasons why the information is being collected, and the usage to which the information is likely to be put. The website categorically states that it does not share users' PII with anyone.
